## SPECIAL MEMO

### TEAM ENTRY RENEWAL DEADLINE

Sponsors who wish to be assured of re-entering their team in the same league as last year must return their team entry contract along with the proper fee to the Adult Sports Office, either in person or by mail, no later than 5:00 P.M. by on **THE SPECIFIED DEADLINE DATE LISTED BELOW (LEAGUE SPECIFIC)**.

### TRANSFER REQUESTS

Teams wishing to transfer to a different league than last year are advised to turn in a transfer request with the renewal contract. These requests will be reviewed on **THE SPECIFIED DEADLINE DATE LISTED BELOW (LEAGUE SPECIFIC)** and teams will be moved if possible. Keep in mind that if the league you wish to transfer into is full, you will remain in the same league that you played in last year.

### NEW TEAM ENTRY

Entries from new teams will be accepted on a first-come, first-served basis at the Adult Sports Office, 5225 W. Vliet Street, Room 163 starting at 8:00 A.M. on **THE SPECIFIED DEADLINE DATE LISTED BELOW (LEAGUE SPECIFIC)**.

## **SPONSORSHIP OF TEAM**

A sponsor's establishment must be located in the City of Milwaukee in order to be considered a "City of Milwaukee Sponsor." Sponsors outside the City of Milwaukee must add \$50.00 to their entry fee. Any team withdrawing from a league prior to the schedules being produced, will be refunded **one-half of the entry fee**. No refund will be allowed for a team(s) for league withdrawal once schedules have been published for the season.

## **ALL-CITY TOURNAMENT**

**The 2012 All-City Softball Tournament will be held Monday, Aug. 13<sup>th</sup> – Friday, Aug. 17<sup>th</sup>.** The All-City Tournament will be comprised of a three divisions: Men's Classic, Men's Social, and Women's Open (Supersaver Leagues do not participate in the tournament). **SPECIAL NOTE:** All teams that qualify for the All-City Tournament must pay a **\$25.00 tournament fee** if they wish to participate. This fee is due to our office by August 3rd, 2012. Failure to pay this fee will disqualify your team from post-season tournament play.

## **PLAYER/COACH ELIGIBILITY**

- A. Every player must be officially registered, having a player card on file at the Adult Sports Office before being eligible to play.
- B. Individuals are eligible to play by filling out an individual player card and paying the \$15.00 player fee, which is non-refundable.
- C. Teams may have an unlimited number of players on their roster, however, only up to 15 players are assessed the \$15.00 player fee. Each additional player beyond 15 is free but must still register by having a player card on file in order to be a legal player.
- D. All participants must reside in the State of Wisconsin.
- E. **Participants must be at least 18 years** of age at the time of registration.

## **FORFEIT FEE PROCEDURE**

A team that forfeits a game will be charged a **\$30.00 forfeit fee**. This fee is due immediately after the forfeited game. If the fee is not paid before the next scheduled game, a team may be dropped from the league. A team with an outstanding forfeit fee at the end of the season must pay the fee in order to renew their contract the following season.
